## Rural Fire Service Policies and Procedures

The primary obligation of the Town of Burns and its Fire Department is to the citizens and property within its corporate limits.

- 1. The Town of Burns will answer calls for fire-fighting assistance outside its corporate limits to approved applicants, who have agreed to be bound by these policies and procedures.
- 2. No application will be accepted unless accompanied by the first annual payment based on .1% of the improvement value of the property. The minimum is \$150.00 and maximum is \$300.00.

The insuring agent or company shall be required to verify in writing that the applicant has insurance coverage for this service; and the company agrees to notify the city of any cancellation of this service.

Each application shall be limited to one (1) residence and one (1) accessory building provided it is reasonably accessible to fire-fighting equipment. The applicant shall pay a fee of \$50.00 for each additional accessory building to be covered.

Commercial buildings shall be covered the same as residences.

## The deposit shall be non-refundable and non-transferable.

- 3. In order to maintain rural fire service protection, each applicant shall pay the fee amount determined per year. The sum shall be payable annually on such a date as established by the Fire Chief. In the event of non-payment of this annual fee, the Town of Burns will automatically cancel such service and notify your insurance company.
- 4. All applications shall contain the address and a general description of the property to be provided rural fire service.
- 5. In the event the city answers a fire call, the applicant agrees to submits another certificate of insurance to maintain rural fire service.
- 6. The Town of Burns will not be responsible for damages or injuries to applicants or their property because of unavailability of personnel or equipment, whether previously committed or otherwise.
- 7. The Town of Burns may reject a request for rural fire service or may depart from the scene of a rural fire if in the discretion of the senior fire official either personnel or equipment of the Town of Burns are necessary to meet another emergency.
- $\pmb{8}$ . Any liability of the Town of Burns shall be governed by the provisions of T.C.A. 29-20-101, et seq.
- 9. The Town of Burns shall have no obligation to provide rural fire service until application is filed and approved by the Fire Chief for the Town of Burns or his designated representative.
